**ORDER:**

In the G.O. 1<sup>st</sup> read above Government have constituted Lake Protection Committee for conservation and protection of lakes in Hyderabad Metropolitan Development Authority area.

2. During the review meeting held on 04-04-2018 the Vice-Chairman, Kakatiya Urban Development Authority (KUDA), Warangal and Commissioner, Greater Warangal Municipal Corporation (GWMC), Warangal have brought to the notice of Government that there are nearly (267) lakes in the GWMC area. After careful consideration of the matter it is felt that there is a need to constitute Lake Protection Committee for GWMC Area within KUDA for conservation and protection of lakes on the similar lines of Lake Protection Committee of Hyderabad Metropolitan Development Authority (HMDA).

3. Accordingly, Government hereby constitute the Lake Protection Committee for preservation and protection of lakes in Kakatiya Urban Development Authority area with the following members:

5/10/2013 The following are the functions of the Lake Protection Committee:

- i Listing of all lakes along with their FTL in GWMC area within KUDA
- ii Wide publicity and awareness campaign for protection of the lakes
- iii To prepare action plan for de-silting the lakes and inflow channels and such other measures required for maintenance or cleaning of the inflow channels into the lakes and issue instructions / guidelines to the concerned agencies for implementation of action plan.
- iv Removal of existing encroachments in the FTL and foreshore areas.
- v To clearly demarcate the lakes upto FTL by raising bunds along FTL and arranging for watch and ward for preventing future encroachments and misuse of the lake environment.
- vi To work out and suggest modalities for regulation and rehabilitation of existing activities / structures.
- vii To do such other things as may be incidental or conducive to the efficient administration for protection and improvement of the lakes and their catchments.
